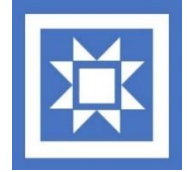

Additionally, I understand that it is my responsibility to comply with the rules and regulations regarding the operation of Golf Carts or s upon City streets as set by the City of Kalona in Ordinance No. 2022-346 and the State of Iowa. Violators are guilty of a simple misdemeanor punishable as a scheduled violation under Iowa Code. A Penalty will result in a schedule of City Fines: First Offense - \$100.00 with the possibility of suspension or revocation of permit; Second Offense - \$125.00 plus suspension or revocation of the permit. Suspension or revocation of permit requires City Council approval to be reinstated.

## City of Kalona Golf Cart or Rules and Regulations

### Registration

To register a Golf Cart the following information is required:

- Golf Cart Permit Application
- Proof of Insurance only if expired
- Payment of the \$25 Fee if a new cart.
- Cart Inspection if a new cart.
- Completion of Household Eligible Driver list.

In Compliance Ordinance No. 2022-346

### Rules of Operation

- Golf Carts may be operated only by persons 16 years of age or older with valid driver's licenses.
- Any person without a valid driver's license or 15 and younger IS NOT ALLOWED to operate a Golf Cart on City Streets, even if an adult is present.
- A City permit sticker is provided after a Permit application is submitted. If a new cart a payment of the registration fee is paid in full, and a full inspection is completed and passed by a City Official. (Registration items listed above)
- Permits expire annually on December 31 of the licensed year regardless of the date issued.
- Golf Carts may be operated on CITY STREETS and alleys only between sunrise and sunset, regardless of whether the Golf Cart is equipped with lights.
- Headlights must remain in use during operation.
- Golf Carts shall not be operated on any City Streets at a speed more than twenty-five (25) miles per hour. Posted speed limits must be followed in accordance with the Code of Iowa.
- Golf Carts shall not be parked overnight on City streets or alleys.
- No Person shall ride on, any portion of, a Golf Cart that is not intended for the conveyance of passengers.
- Only one person is allowed behind the steering wheel when operating.
- Golf Carts are only allowed to be driven on city streets or the owner's private property. Golf Carts are not allowed to be driven on sidewalks and trails.
- Golf Carts shall not be operated upon Highway 1, Highway 22, or on the shoulder thereof. unless crossing said streets.
- Golf Carts must obey all traffic signs and signals.
- Operators cannot be under the influence of any intoxicating substance.

Violators of any of the above can be found guilty of a simple misdemeanor punishable as a scheduled violation under Iowa Code. A Penalty will result in a schedule of City Fines: First Offense - \$100.00 with the possibility of suspension or revocation of permit; Second Offense - \$125.00 plus suspension or revocation of the permit. Suspension or revocation of permit requires City Council approval to be reinstated.
